

Proskauer Advises Hg on Closing £1.5 billion Hg Saturn 1

Hg Saturn, a software-focused, large-cap European buyout fund will invest in companies with an enterprise value of approximately £1 billion and above and is a natural extension of Hg’s core technology focus.

The fund received strong support from existing Hg investors, as well as new investors. This closing marks the third fund the Firm has closed for Hg since 2017, following the successful fundraisings of Hg 8 and Hg Mercury 2, which closed on a combined £3.1 billion.
