

# Front and Center: Latest SVO Grant Numbers

**December 14, 2021**

The SBA stopped accepting new SVO Grant applications on August 20, 2021. The SBA is currently reviewing submitted SVO Grant applications and issuing both initial and supplemental awards. As of December 13, 2021, the SBA had made decisions on over 99% of all initial applications. ## **Latest SVO Grant Statistics:**

### **Applications Submitted**

- **17,644** Initial SVO Grant applications submitted
  - In review (SBA is actively reviewing): **38**
  - Awarded (notice of award issued): **12,816**
  - Declined (notice of decline issued): **4,790**
- **8,388** invitations to apply for a Supplemental SVO Grant accepted

### **Initial Awards**

- **12,806** Initial SVO Grants awarded
  - **4,758** – Live Venue Operators or Promoters
  - **3,316** – Live Performing Arts Organization Operators
  - **1,377** – Talent Representatives
  - **1,605** – Motion Picture Theatre Operators
  - **813** – Museum Operators
  - **947** – Theatrical Producers
- **\$10.6 billion** in Initial SVO Grant funding awarded
- Average Initial SVO Grant awarded: **\$829,000**
