

Proskauer Represents Major League Soccer in Exclusive Financing with Syndicate of Black-Owned Banks

NEW YORK, March 18, 2022 – Proskauer, a leading international law firm, today announced that it represented Soccer United Marketing, LLC, an affiliate of long-time client Major League Soccer (“MLS”), in a \$25M loan from a syndicate of Black-owned banks organized by the National Black Bank Foundation (“NBBF”). The landmark financing is the first major commercial deal in which a U.S. sports league has transacted exclusively with Black-owned banks.

The loan marks a significant milestone in MLS’s ongoing commitment to supporting racial justice through economic justice. Through its partnership with the NBBF and other organizations, MLS hopes to raise overall awareness of Black-owned banks and to facilitate similar opportunities for these institutions across the professional sports leagues.

Major League Soccer, now in its 27th season, is the top professional soccer league in the United States and Canada. The league was founded in 1996 and now has 29 clubs throughout the United States and Canada, including 2022 expansion teams Charlotte FC and St. Louis City SC, which will debut in 2023.

The National Black Bank Foundation was formed in 2020 to uplift Black-owned banks and the communities they serve. The nonprofit works with corporate and philanthropic partners, to provide legal, regulatory, and operational assistance to Black-owned banks. Its investment unit, the Black Bank Fund, invests direct Tier 1 capital into existing Black-owned banks through stock purchases.
