

# Proskauer Advises Hollyport Capital on \$2.2bn Hollyport Secondaries Opportunities Fund VIII2

**LONDON, December 15, 2022** - Proskauer, a leading international law firm, announced today that it advised Hollyport Capital, a leading investor making mature private equity investments on the secondary market in a wide range of fund types and geographies, on the formation of its latest fund, Hollyport Secondary Opportunities Fund VIII2, which closed above its target of \$1.5 billion.

The fund secured over \$2.2bn of commitments across the main fund and overage vehicle. Hollyport VIII made its first investment in March 2022 and has, to date, entered into acquisition agreements that will comprise approximately 15% of its target investment programme. Proskauer has advised Hollyport on a number of these deals.

Since 2006, Hollyport has raised and invested seven secondary private equity funds and currently has over \$4.7bn assets under management. Hollyport has evolved with the growth of the legacy private equity market with a heritage that stretches back over 30 years.
