

# Proskauer Advises Isio Group on Agreement to Acquire Deloitte Total Reward and Benefits Limited

**London, January 16, 2023** - Proskauer, a leading international law firm, announced today that it advised the Isio group (“Isio”) on the signing of its agreement to acquire Deloitte Total Reward and Benefits Limited (“DTRB”), the UK pensions advisory business of Deloitte LLP.

The transaction is subject to FCA regulatory approval.

DTRB provides actuarial, pensions administration and investment services to some of the biggest organisations and pension plans across the UK. The acquisition and addition of DTRB’s 200-strong workforce to Isio’s existing team will create one of the largest pensions advisory businesses in the UK once the transaction completes. The enlarged Isio Group will have annual revenues of around £140 million and 1000 employees across its nine existing locations around the UK together with a new location in Belfast.
