- The Women's Sponsorship Program, which selects mid- and senior-level lawyers and pairs them with distinguished partners who serve as sponsors to support their career development and professional growth.

- Proskauer Women's Alliance (PWA), which is led by a steering committee of associates and senior counsel and advised by partners. Throughout the year, PWA hosts several professional development trainings and networking events to increase connectivity and career growth.
- Initiatives to raise the bar of the Firm's DEI strategy and ensure that all voices are heard as well as training focused on inclusive hiring, mentoring and sponsorship across practice groups and inclusive leadership.
