

# Proskauer Advises Fidelio Capital on the Closing of Fidelio III

Fidelio III closed with total commitments in excess of the €1 billion target, demonstrating strong investor demand and more than tripling the size of Fidelio's previous investment mandate. The total capital raised includes a significant commitment from the Fidelio team of more than €125 million.

Founded in 2010 by Gabriel Fitzgerald, Fidelio has made 12 platform investments, with more than 150 add-ons, scaling many of these from small local businesses into global leaders in their respective markets. Fidelio's ambition is to build outstanding businesses without being limited by a pre-determined investment horizon or geographical borders.
