TGL is an innovative golf league developed by sports executive Mike McCarley, Tiger Woods, and Rory McIlroy's TMRW Sports in partnership with the PGA TOUR that fuses technology and live action with teams of PGA TOUR stars competing in a purpose-built arena in Palm Beach, Fla. across a season of primetime matches starting in January 2024. Technology is a foundational element of TGL, offering fans an innovative, shorter format presentation of team golf, featuring some of the PGA TOUR's biggest superstars.

"TMRW Sports continues to break new ground in the worlds of sports and technology," said Rob Freeman, co-head of Proskauer's Technology, Media & Telecommunications Group and a member of its Sports Law Group. "We are thrilled to continue to partner with TMRW Sports in their growth and success and are excited to welcome LAGC to the TGL league."
