

# Proskauer Advises MLS in Signing Lionel Messi

**NEW YORK, July 21, 2023** - Proskauer, a leading international law firm, announced today that it advised Major League Soccer (MLS) in its agreements with soccer icon Lionel Messi, a seven-time Ballon d'Or winner and FIFA World Cup champion, to play for Inter Miami FC.
