

## Bart Williams Named a 2023 Leader of Influence by the Los Angeles Business Journal

LOS ANGELES, July 24, 2023 - Leading international law firm Proskauer is pleased to announce that partner Bart Williams has been named a 2023 Leader of Influence: Litigators & Trial Attorneys by the *Los Angeles Business Journal*. This honor recognizes leading lawyers for their professional achievements, community leadership, milestones and notable accomplishments over the past year.

Bart is chair of the Firm's Litigation Department and head of its Los Angeles office. As one of the nation's most sought-after trial lawyers, Bart is a strategic and persuasive litigator with deep experience across commercial litigation, white collar criminal defense and internal corporate investigations. He is frequently called in just months or even weeks before a trial to deliver a win.

He recently led the trial team that secured a significant victory for Gilead Sciences, Inc. in a \$3.6 billion antitrust case on allegations that the pharmaceutical company struck an anticompetitive "pay-for-delay" patent settlement related to two HIV medications. A California jury delivered a full defense verdict following a six-week trial. The verdict is only the third ever in reverse payment cases of this type, and the first ever to find for the defense on grounds of the absence of a payment and the absence of market power for the brand in the relevant market. The jury's findings affirmed that a 2014 patent settlement between Gilead and Teva did not violate antitrust law and did not constitute an illegal reverse payment.

Outside of the courtroom, Bart is the founding co-chair and member of the Board of Advisors of the Los Angeles Metropolitan Debate League (LAMDL). Now in its 15<sup>th</sup> year, LAMDL has grown to be the policy debate portal to 30 schools, serving more than 650 students per year with a goal to serve over 1,000 students from 50 schools by the end of 2024. In addition to serving on Proskauer's Diversity Task Force, Bart is also a member of the Board of Trustees of the Jules Stein Eye Institute at UCLA, a member of the Board of Directors of the LA84 Foundation and a fellow of the American College of Trial Lawyers.

Earlier this year, Bart was also named a 2023 Leader of Influence: Minority Attorneys by the *Los Angeles Business Journal*, a 2023 Visionary by the *Los Angeles Times'* Business of Law and a Leading Commercial Litigator by *The Daily Journal*.
