

Proskauer Secures Defense Win for Sanderson Farms in \$7 Billion Antitrust Jury Trial

Full Defense Verdict in One of the Largest-Ever Agriculture Industry Antitrust Trials in the U.S.

NEW YORK, October 26, 2023 - Proskauer, a leading international law firm, announced today that it secured a landmark victory for Sanderson Farms in a blockbuster broiler chicken antitrust conspiracy case. Following a six-week trial, a jury in the U.S. District Court for the Northern District of Illinois delivered a full defense verdict, rejecting the Plaintiffs' claims that alleged that Sanderson Farms participated in a supply reduction conspiracy with other producers in the broiler industry between 2008 and 2012.

The Proskauer team defeated \$7 billion in damages claims, which – had the jury ruled against Sanderson Farms – would have been tripled by statute to \$21 billion. The defense verdict was one of the largest-ever antitrust jury trial wins involving the U.S. agriculture industry.

"We are pleased that, after a full and fair trial, the jury has rendered a unanimous verdict in favor of Sanderson Farms on all counts. Today's verdict vindicates Sanderson Farms and shows that the Plaintiffs' case ignored fundamental truths about Sanderson Farms and the nature of the chicken industry," said Jeremy Kilburn, Chief Legal & Compliance Officer at Wayne-Sanderson Farms.

"We thank Sanderson Farms for using Proskauer as their trial team and for being a true partner throughout the trial, and for having the confidence that they would be vindicated. We focused on presenting the clear evidence that Sanderson was the only company to build and ramp up new production plants during an alleged supply reduction conspiracy, and that different companies made individual production decisions during the crisis of the Great Recession and high feed costs. We appreciate the jury's efforts in such a long trial, and for returning a verdict that there was no conspiracy," said Chris Ondeck, Co-Chair of Proskauer's Antitrust Group.
