Both team investors and XGL athletes will have a platform from which to build and generate additional revenue streams through sponsorships and team-specific merchandise. In an industry first, XGL athletes will be provided with a level of stability that includes guaranteed compensation as well as new commercial opportunities.

X Games League will have both a Summer XGL and a Winter XGL – each initially composed of four global events and a minimum of four teams, with plans to grow. The competition schedules will include X Games signature events as well as strategic collaborations with existing competitions.
