Chris Ondeck serves as co-chair of the Firm's Antitrust Group and head of its Washington, D.C. office. The verdict was the third ever in reverse-payment cases of this type and the first ever to find for the defense on grounds of the absence of a payment and the absence of market power for the brand in the relevant market.
