A first-chair trial lawyer, Hadassa served as lead counsel in numerous federal jury trials, some of which spanned many months, involving securities fraud, wire fraud, mail fraud, tax fraud, money laundering, cybercrime and corporate criminal liability, homicide, arson and other crimes of violence. Hadassa has also second-chaired and supervised scores of additional trials.

As a federal prosecutor, Hadassa led scores of investigations resulting in criminal charges. She served as Co-Chief of the General Crimes Unit, where supervised approximately fifty prosecutors, oversaw thirty trials and managed hundreds of prosecutions.

Before joining the Department of Justice, Hadassa focused on employment defense at a Wall Street law firm, where she represented corporate employers and senior executives in connection with Title VII claims and its state law equivalents brought before arbitration panels, and in state and federal court.
